Dear Editor:

I am dismayed by the inaccurate and simplistic conclusions that were drawn by Colin Craig in his article, *Cost of education could use a good pruning*, printed Friday, March 19, 2010. Mr. Craig has concluded that because enrolment is falling, the cost of education must also fall. Mr. Craig's position does not take into account the reality of education in the 21st century.

Mr. Craig does not recognize the tremendous challenges schools are faced with today. Schools today offer a broad array of services ranging from breakfast programs, language programs, information computer technologies, vocational programs, various music and sport programs to advanced placement and international baccalaureate programs. In this century, teachers and schools are trying to meet the needs of **all** learners, including those with the greatest needs. Naturally, providing a broad array of services such as these has a cost attached.

The implementation of Bill 13, which strives to assure appropriate education services to children, has resulted in the addition of thousands of positions in the school system including Educational Assistants, clinicians and special education teachers. This major undertaking helps improve special needs education for this segment of the school population, but has resulted in increased costs.

Over the last decade, Manitoba has witnessed high levels of immigration not seen in recent memory. EAL students represent another challenge and an ever increasing cost to our educational system.

While it is convenient for Mr. Craig to target teacher raises as "the biggest cost driver", it is incumbent upon him to present accurate information in this regard. Mr. Craig states that teacher raises are "always above the inflation rate" while in actual fact, on average, a Manitoba teacher today is paid about 5% less (measured in real dollars) than a teacher in the early 1980s.

So, why does Mr. Craig deem Manitoba's school system "broken" and in need of reform? The OECD has consistently remarked that Canada has one of the best performing education systems in the industrialized world. What is Mr. Craig's real agenda? Simply stated, one must assume that it is to attack teachers, their salaries and their unions.

Blue Cross Vision Plan

At the May 25th Staff meeting, LRTA members voted on the inclusion of the Blue Cross Vision Plan in the LRTA Extended Health Benefit package. In order for Vision Care to become part of the Extended Health Benefit package, 2/3 of those casting ballots needed to support inclusion. The results of the vote are as follows:

Number of ballots cast: 904
In support of including the Blue Cross Vision Plan – 368
No support of the Blue Cross Vision Plan – 530
Spoilt ballots – 5
Abstention – 1

41% of those casting ballots supported inclusion of the Vision Care Plan before the vote is lost.
