Election Results

LRTA is proud to announce that Valérie Rémillard, a LRTA member currently serving as ÉFM President, was elected to the MTS Provincial Executive for a two-year term.

AGM Resolution Highlights

- A resolution was passed affirming the position of the Society that Principals and Vice-Principals are 'principal' teachers and that any attempt to separate them from the Society shall be met with opposition.
- Recommendations from the MTS Women in Education Leadership Commission were approved by delegates.
- Due to complaints from members who feel access to PD is being hindered by availability of substitutes, the Society will investigate the lack of certified substitutes, and the use/misuse of uncertified substitutes.
- The Society will request that Manitoba Education and Training review and embed mental health education into K-12 curricula.

MTS Rally for Public Education

More than 1.500 Manitoba public school teachers attended the Rally for Public Education on Friday, May 25th. Chanting, "Kids not cuts!", members were loud and vocal about their concerns with reductions to provincial education funding and how it is negatively impacting students in the classroom.

MTS President Norm Gould spoke of various government actions that have impacted classrooms already or will in the future. Meanwhile, MTS members Michelle Jean-Paul and Tammy Tutkaluk spoke with passion and conviction about impact provincial funding cuts are having on their students and our ability as teachers to meet their many diverse needs.

MTS Supports Poverty Initiatives

MTS has thrown its support behind initiatives aimed at reducing poverty in Manitoba.

The Society's provincial executive voted recently to contribute \$1,000 on behalf of Manitoba teachers to Make Poverty History, a collaborative coalition representing business, education, student, youth, Indigenous, newcomer, labour, women's, disability, urban, rural, and northern communities. The coalition is committed to changing public policy to achieve a Manitoba without poverty.

MTS has also started a series of radio ads to encourage Manitobans to participate in an online survey launched by the provincial government. The survey is intended to collect opinions in advance of development of a comprehensive poverty reduction strategy.

Teachers are keenly aware of how poverty affects a child's ability to learn. Students without safe housing and nutritious food struggle to be successful and form healthy relationships. That means difficulty in classes, health issues, and stress on social programs. It's an issue facing Manitoba teachers every day, as they work to support students who arrive at school without the fundamental supports they need to focus and achieve. One in four children in the province lives in poverty, and the rates are even higher for Indigenous children.

Injunction on Bill 28

On May 29th and 30th, the Manitoba Teachers' Society was represented by legal counsel as part of the Partnership to Defend Public Services (a coalition of public-sector unions) challenging Bill 28.

First, some background on Bill 28. *The Public Services Sustainability Act* (commonly referred to as Bill 28) calls for all public-sector workers to have their wages frozen for two years, followed by mandated maximum increases in salary of 0.75% and 1.0% in the third and fourth years of any contracts. In addition, Bill 28 will restrict any increases in other remuneration for public-sector workers. If fully implemented, Bill 28 would effectively reduce purchasing power, when compared to inflation, by 6.2%, or approximately \$15,000 for every teacher.

The Government of Manitoba introduced Bill 28 on March 20, 2017. It was passed by the Legislature in June 2017, but has not yet been proclaimed. Essentially, this means it should not be having any effect on current bargaining, but it seems to be.



In the eyes of MTS, and in the eyes of the other public-sector unions, "Bill 28 shows a blatant disregard for the collective bargaining rights of workers." As a result, a legal challenge was launched on July 4, 2017 to prove that Bill 28 is unconstitutional.

The specific matter in front of the Manitoba Court of Queen's Bench on May 29th and 30th was the request for an injunction against Bill 28. An injunction can be thought of as a "pause" button, meaning that none of the provisions of Bill 28 could be enacted until after a ruling is made on its constitutionality. This will involve a challenge to the Supreme Court of Canada.

During the injunction hearing, the Partnership to Defend Public Services provided arguments regarding the necessity of this injunction. At the end of the two days of presentations, the judge retired to write his ruling. The ruling is to be rendered by next month.

Should this injunction be returned in favour of the Partnership to Defend Public Services, then bargaining can resume with no restrictions on negotiations. Should this injunction be rejected, then the Government could proclaim Bill 28 and freeze the salaries of 120,000 public-sector workers. This was a first step in what will be a long and slow process. MTS will continue to stand with other public-sector unions against Bill 28 to help defend working people against the attacks on their constitutional rights to bargain.
